

Volunteer Release and Waiver of Liability Form

Within this document, "ROTARY CLUBS" refer to QUITMAN and MINEOLA ROTARY CLUBS of TEXAS.

This Release and Waiver of Liability (the "release") executed on _____ by (name of volunteer candidate or volunteer group leader) _____ ("Volunteer") releases **ROTARY CLUBS** a nonprofit corporation organized and existing under the laws of the State of Texas and each of its directors, offices, employees, and agents. Volunteer understands that the scope of Volunteer's relationship with **ROTARY CLUBS** is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that **ROTARY CLUBS** will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to **ROTARY CLUBS**.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless **ROTARY CLUBS** and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to **ROTARY CLUBS**. I understand and acknowledge that this Release discharges Nonprofit from any liability or claim that I may have against **ROTARY CLUBS** with respect to bodily injury, personal injury, illness, death or property damage that may result from the services I provide to **ROTARY CLUBS** or occurring while I am providing volunteer services. This applies to any ETFB Distributions performed in Quitman, Tx and Mineola, Tx.
2. Insurance: Further I understand that **ROTARY CLUBS** does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of **ROTARY CLUBS** beyond what may be offered freely by **ROTARY CLUBS** in the event of such injury or medical expenses incurred by me.
3. Medical Treatment: I hereby Release and forever discharge **ROTARY CLUBS** from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Nonprofit.
4. Assumption of Risk: As a volunteer, I hereby expressly assume the risk of injury or harm from these activities and Release **ROTARY CLUBS** from all liability for injury, illness, and death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.
5. Photographic Release: I grant and convey to **ROTARY CLUBS** all right, title, and interests in any and all photographs, images, video or audio recordings of me or my likeness or voice made by **ROTARY CLUBS** in connection with my providing volunteer services to **ROTARY CLUBS**.
6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas and the State of Texas. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
